### Korean Air and Delta Air Lines to strengthen partnerships with WestJet



Korean Air and Delta Air Lines will strengthen their respective partnerships with WestJet through the purchase of minority equity stakes in the Canadian airline from Onex Partners, the upper middle market private equity platform of Onex, a Canadian investor and alternative asset manager. Affiliated funds and co-investors of the Onex Group intend to participate in the sale alongside Onex Partners. These investments build on each airline's existing relationship with WestJet to provide further benefits to customers in North America, Europe, Asia and beyond.

Under the agreements announced today, Korean and Delta will acquire independent equity stakes totaling 25% in WestJet. Delta will be investing US\$330 million and acquiring a 15% stake, and Korean will invest US\$220 million in exchange for a 10% stake.

Upon closing, Delta has the right and intent to sell and transfer a 2.3% stake in WestJet to its Joint Venture partner Air France-KLM, also an existing WestJet partner, in exchange for US\$50 million. This separate transaction would remain subject to certain Air France-KLM approvals. The Onex Group will continue to own and control Calgary, Alberta-based WestJet.

## Korean Air employees lend helping hands in Nepal and Mongolia



Korean Air recently carried out a series of volunteer and environmental initiatives in Nepal and Mongolia, reaffirming its ongoing commitment to the global communities it serves.

From May 19 to 24, members of one of Korean Air's in-house volunteer groups traveled to Chitwan, Nepal - located about 150 kilometers southwest of Kathmandu - to support a local children's daycare center. While the region is known for its rich natural environment and designated as a UNESCO World Heritage site, it continues to face critical shortages in basic infrastructure such as electricity, gas, healthcare and education.

The 22-member volunteer team, including airline employees and their family members, installed drainage equipment to provide a stable supply of clean drinking water. They also performed maintenance and repair work on the center's playground and aging facilities. A special community event was held where volunteers served meals, played games and distributed school supplies. To help address health challenges linked to the region's hot and humid climate, the team donated nutritional supplements, fever reducers, ointments and deworming medication. ## Korean Air to build urban air mobility hub in Bucheon



Korean Air is investing KRW 1.2 trillion to build a next-generation Urban Air Mobility (UAM) and Aviation Safety R&D Center in Bucheon, Gyeonggi Province to create a major new hub for future mobility and aerospace innovation in Korea.

The ambitious initiative reflects Korean Air's long-term vision to lead the future of aviation through advanced technology, world-class training and sustainable development. The new facility will serve as a central base for research, pilot training, and aviation safety advancement, strengthening the airline's capabilities as it prepares for a new chapter following its integration with Asiana Airlines.

On April 30, Korean Air formalized the project through a signing ceremony with Bucheon City at the Bucheon Arts Center. The event was attended by key stakeholders including Keehong Woo, Vice Chairman of Korean Air; Yong-eek Cho, Mayor of Bucheon; Han-Joon Lee, CEO of Korea Land and Housing Corporation (LH); and Myung-hee Won, CEO of Bucheon Urban Development Corporation.
